

**Zumbro River Canoe Race  
Waiver of Liability & Release**

In consideration of being allowed to participate in any way in the Zumbro River Canoe Race, the undersigned acknowledges, appreciates and agrees that:

1. The risk of injury from canoeing, kayaking and/or other water activities on the Zumbro river or lake is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERS, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and terms for participations. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
4. I release any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the canoe race and/or other activities associated with the canoe race on Camp Victory property; and,
5. I do hereby grant and convey unto Camp Victory Ministries all right, title, and interest in any and all photographic images and video or audio recordings made for publicity and other purposes; and,
6. I, for myself and behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS Camp Victory Ministries and all event sponsors, its officers, directors, officials, agents, employees, volunteers, members, guests, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of real property and personal property used to conduct the event and activities (“RELEASEES”) WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEE OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW.

I have read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement.
